Creating Evidence on Unsafe Abortion to Advocate for Public Sector Services

Access to safe abortion services is an important matter of reproductive rights of women which is necessary to live a healthy life. Almost in all the districts of Uttar Pradesh, there is very low level of awareness and knowledge among communities regarding access to safe abortion. Often it is seen that women suffer from unwanted or unplanned pregnancy due to multiple reasons and they need access to safe abortion services. The reasons behind unintended or unplanned pregnancy are unavailability of contraceptives, failure of sterilization, restricting the reproductive capacity etc. Many times unwed adolescent girls become pregnant due rape and many other reasons and they need abortion care. In such situation, women in Uttar Pradesh want to get safe abortion services but due to its stigmatization and several myths related with abortions, they become helpless to choose unsafe abortion services and put their life in risks. There is a widespread perceptions regarding abortion in the community that it is a sin and a murder. So they don't want to disclose it in the society and secretly terminate the pregnancy. Due to this they bear the physical, mental and economic loss. In the families too, they pressurise women to give birth to the child and don't allow abortion. In many families women with abortion faces discrimination in their families such as they are not allowed inside the kitchen in their homes, they don't receive food till 1 month etc. During abortion service many women suffer from complications. When there is excessive loss of blood then they go to hospital either with ASHA or with family members and suffer from huge economic loss. Even today, Abortion is considered as a stigma and a sin. Almost in all the district there is a lack of awareness among women regarding Medical Termination of Pregnancy Act and they dont consider abortion as their right.

3.3. Enhancing Quality Education Through Better School Governance (BSHA)

Supported by change Alliance

BSHA is a state level network working on enhancing the quality of education being imparted in government schools by strengthening the school governance system and promoting effective partnership for betterment of school environment.

The Gramin Punarnriman Sansthan organized this activities in 5 Primary Schools (Vaishpur, Thiraipatti, Chhitauni, Meerpur and Pakardiha) of Atraulia block of Azamgarh with support of Behtar Shiksha Haq Abhiyan (BSHA) joint collaboration with SMCs and education department which runs a “School Chalo Abhiyan “ or Go to School Campaign” before the commencement of the academic session every year. Koi bachcha chhut na paye , har bachcha school ko jaye (Let not a single child be omitted and let each child go to school)

SMCs played an influential role in success of the enrolment campaign because they have a better idea of children in their village. That’s why, under the RTE Act, SMCs are assigned the responsibility to ensure enrolment in schools. The campaign provided a good opportunity for SMCs to establish their identity as a significant and influential committee to improve the enrolment as well as retention record of government school.

Coalition on Child Rights and Development (CCRD)

Supported by change Phia Foundation and Unicef

Development (CCRD) is a initiative on which PHIA Foundation is working with 14 CSOs in developing the Citizen report , improving basic requirements under Grievance redressal, improving student –teacher ratio, ”**Har Bachha School Mein**” Abhiyaan etc.

Gramin Punarnriman Sansthan is also one of the partner organizations. Gramin Punarnriman Sansthan is collectively working on the issues related to child right and development, inclusive quality education to ensure the overall development of children and reduction in school dropout rate. The program aims at promoting and strengthening a strong alliance on Child Rights in Uttar Pradesh through an association of civil society organizations, like minded networks, academicians, individuals, and private sector agencies. It also works to ensure holistic rights of children through alliance building of CSOs and other stakeholders in 14 districts of Uttar Pradesh. Gramin Punarnriman Sansthan as one of the partners is working in 5 selected government primary schools of Azamgarh .

Sustainable Agriculture

Seed multiplication/ demonstration of zinc fortified variety of wheat-BHU 6

GPS has demonstrated Zinc fortified variety of wheat in 14 village of Atraulia and Pawai block in district-Azamgarh. This programme was supported by ICRISAT under the leadership of SHDA, Gorakhpur. A total of 120 farmers were selected for seed production/ multiplication of BHU-6 covering 50 acres of land in block Atraulia and Pawai of district Azamgarh. Training on rogging and maintaining isolation distance has been imparted in the selected districts by SHDA.

Agronomical performance- Tillering- 4-15 per plant. Plant height-Average 3.10 ft. Average production was 4.5 tone/ha

Crop cutting- GPS followed crop cutting within 5.0 sq meter area at 3-4 demo sites in presence of community. Thereafter calculated per ha production and income that is being sketched in following manner-

Farmers' Feedback

- Great willingness in farmers to scale up this variety as it is zinc fortified and nutritious than other varieties. Most of the farmers reported good quality of *chapati* than other local checks.
- Most of the small and marginal farmers are supportive to adopt this variety as they get more straw to feed their cattle. It is because of good height of plants.
- It is a common feedback from the farmers that there should also be made available zinc fortified varieties of wheat with small size of plants.

Celebration of World Women's Day

Phoolan Devi Nari Mahasangh, Mahila Swasthay Adhikar Manch, MASVAW and Gramin Punarnirman Sansthan is jointly celebration organized a district level rally from Jaji Maidan to Mehta Park and open meeting in Azamgarh World Women's Day on 8th March 2018. 450 Women are participated this event. Women's are discuses issues on Right to Work, Food, Health, Domestic Violence and Gender issues in PRI also.

Project Akshay

Gramin Punarnirman Sansthan implemented project Akshay in Blocks Mirjapur of Azamgarh district with partnership of Voluntary Health Association of India (VHAI)

Goal of project Akshay: To decrease morbidity and mortality due to drug resistant TB (DR-TB) in U.P. and improve access to quality TB care and control services through enhanced civil society participation

Objectives of project Akshay :

1. Establish and enhance capacity for quality assured rapid diagnosis of DR-TB.
2. Scale-up care and management of DR-TB in Azamgarh district resulting in the initiation of treatment of Drug Resistant TB (DR-TB) by 2017
3. Improve the reach, visibility and effectiveness of RNTCP through civil society support in Azamgarh district.
4. Engage communities and community-based care providers in Mirjapur block of Azamgarh district across the state by 2017 to improve TB care and control, especially for marginalized and vulnerable populations including TB-HIV patients.

AIDS Awareness Program

Awareness is the only cure to combat HIV and AIDS. Azamgarh is most migrational district of eastern U.P. The community people have very little awareness about AIDS. The organization has been involved in awareness building since it started its programme in Atraulia Block. The World AIDS day is celebrated by a seminar with 400 youth on the issue of HIV/AIDS and STD's, distributing pamphlets and posters and community meeting in 40 ERW GPs working area of GPS.

Strengthening ECCD in Uttar Pradesh through Advocacy, Capacity Building and Action Research

Overall Goal: By 2015, all children (under six) especially from vulnerable and marginalized communities realize their right to holistic development through strengthening existing government and community systems.

Program Objectives

- All children in the 0-6 age group have access to quality programs that promotes age-appropriate development
- All children in the 0-6 age group have a safe and stimulating environment

CLIMATE CHANGE 100% UP CAMPAIGN

In 2016-17, Care4Air conducted community mobilization activities with 100 % UP campaign. It was done in order to bring all political parties to one platform and make them commit certain promises regarding cleaning the ambient air as well as introducing renewable as the only alternate.

An intense community mobilization campaign was planned in Varanasi, the Parliamentary constituency of Indian Prime Minister, while a partnership was also built with other civil society organizations working in different cities. Whole exercise was planned to raise issues like bio mass burning, poor waste management systems, uncontrolled construction, poor public transport etc to find out a way to control rising air pollution.

The goal was to knock all political parties and the electorate on this issue and to create an opportunity within the campaign where all political parties could come on one platform to announce their priorities regarding CleanUP.

This campaign received wider support and civil society organizations, middle class associations, media groups etc came forward and made this campaign possible in 30 different districts and cities of UP. All leading political parties incorporated campaign's key demands into their political manifesto. It's the high time when a statewide campaign should be built on the massive support garnered last year to push the government for a big reform in terms of mass transit systems, renewable energy, air quality monitoring and health advisories in the state. The campaign

Intervention:

The campaign will run on three different dimensions. Activities are designed to involve network partners in order to mobilize public which will finally push the government to fulfill its poll promises.

One part of the campaign will involve in strengthening the network partners through capacity buildings with the help of IEC materials, and to help them organize activities around the campaign

narratives. It will enable them to take leadership within the campaign which will eventually strengthen the campaign itself. For this to happen smooth, a secretariat will be formed in Varanasi which will function to improve the coordination, communication within the campaign and to help new allies build a clearer narrative of this clean air campaign.

All public mobilization activities are strategically distributed among different cities and districts. There are some cities and districts where 100 % UP campaign was intense last year. Such places will not be engaged in previously conducted activities where as newer cities will replicate mobilization events of last year, with necessary changes as per understanding among the local public and their culture.

We aim to amplify the campaign's voice in cities where 100 % UP campaign is already functioning as well as create a discourse on RE Policy and Clean Air Action Plan in those cities which will participate in the campaign for the first time.

The political mobilization activities will focus upon reminding the newly formed state government its poll promises around environmental issues. The aim is to take the demand of clean air action plan and RE policy for the state to one more step ahead and to get the process initiated by the government to form these two essential documents for the state.

Campaigns for Comprehensive Sexuality Education

Gramin Punarnirman Sansthan in collaboration with The Y P Foundation New Delhi organized a Campaigns for Comprehensive Sexuality Education in 5 Villages of Atraulia block of Azamgarh district. duration of 5 months (from May 2018 to October 2018)

The Project shall endeavor to achieve the following goals and outcomes, with a specific focus in Gramin Punarnirman Sansthan

- To carry out campaigns that will advance young people's access to information on sexual and reproductive health in UP
- Create a cadre of youth leaders who are aware of their rights and policy entitlements on SRHR information and service access and ready to take on-ground action to demand their rights.

Work with Man and Boy's

GPS collaboration with Sahayog and MASVAW (Men's Action for Stopping Violence Against Women) implement Ek Sath campaign in 5 GPs of Atraulia block focus on male participation in family planning, issues related to health, gender equality and social justice. An important component of its work has been working with men and boys in combating violence and discrimination against women at both the personal and community levels.

Kishan Club (Formers clubs) Program

GPS form 5 kishan clubs in development block Atraulia 105 formers associated. The formers meeting every quarter and organized expert with meet program two time in year for scientific agriculture practices this program is supported by NABARD.

SATHI District Forum Azamgarh (SDF)

SATHI District Forum is part of SATHI Uttar Pradesh 18 organization of Azamgarh district member of this forum. SDF members time to time organize Members capacity building program on RBA, Documentation, Resource Mobilization and campaign, workshop, Dialogs different issues . SDF convener organization Gramin Punarnirman Sansthan.

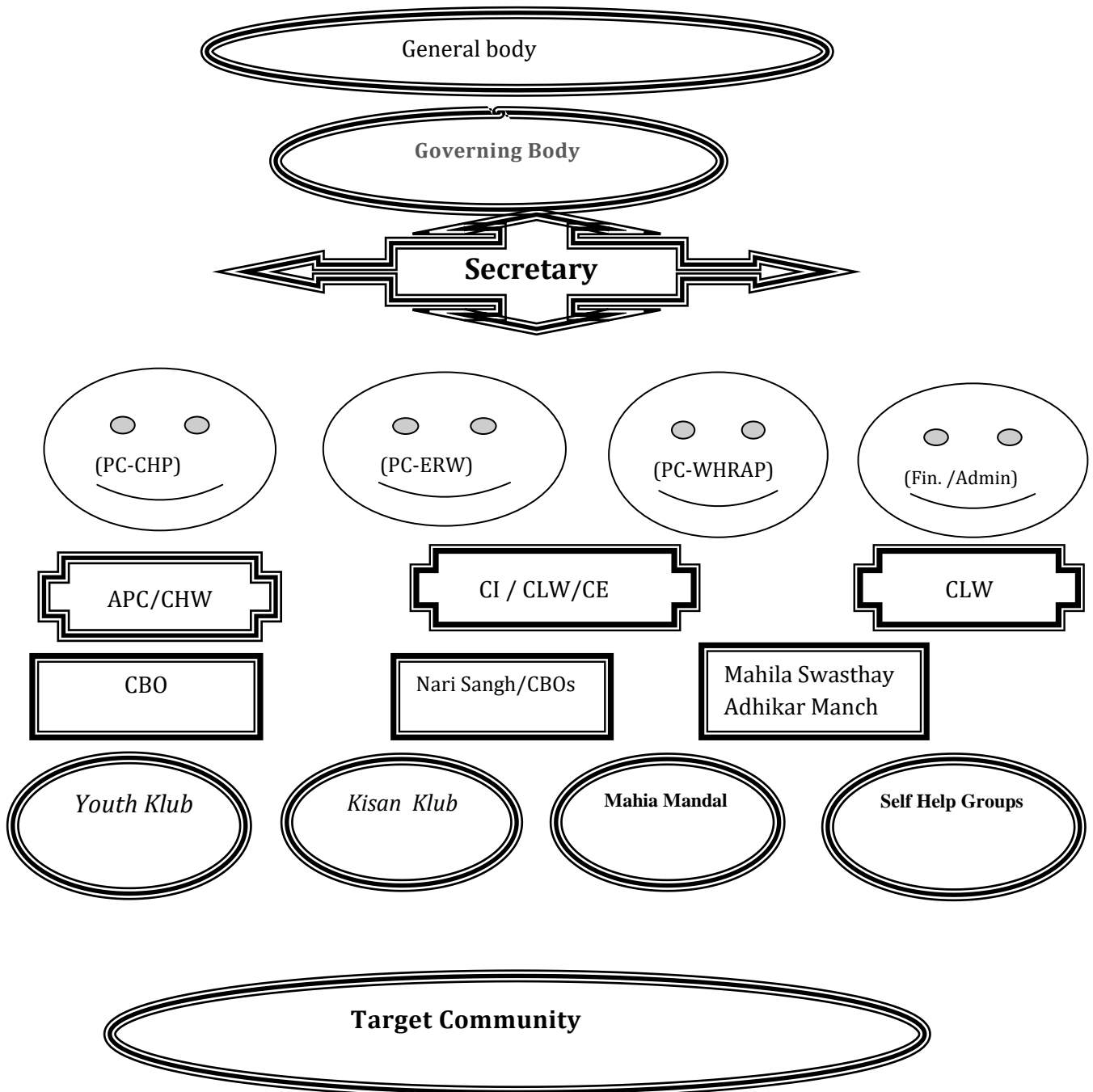
